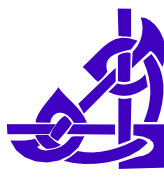

IRISH WOLFHOUND FOUNDATION (IWF) HEART STUDY

As part of the Life Cycle Study, The Irish Wolfhound Foundation will sponsor screening for cardiac health at the show site on Sunday, April 2. A donation of \$60 is requested for EKG/auscultation for hounds under 6 and \$30 for hounds 6 and older. Any hound found to have an abnormal EKG or auscultation will be worked into the echo clinic and a \$100 donation will be requested. Testing for OFA certification will be available but must be requested when you sign up. Echocardiogram/EKG (required for OFA cert.) will be \$200 for healthy dogs 2 years and under 6 year of age & \$100 for dogs over 6 years of age. SWEEPSTAKES - REQUIREMENTS & CLASSIFICATION

Dogs shown in Sweepstakes must be entered in one of the regular classes at the regular entry fee and on the regular entry form. Indicate your Sweepstakes Class with the age division in the space provided for "Additional Class". Champions of Record may not be entered. The following classes will be provided for both dogs and bitches:

Junior, 6 Mos & Under 9 Mos; Junior, 9 Mos & Under 12 Mos
Senior, 12 Mos & Under 15 Mos; Senior, 15 Mos & Under 18 Mos

Division of Entry Money As Prizes

35% of the total Sweepstakes entry fees will be retained by the Club for expenses. The remaining 65% will be divided as follows:

First - 40% Second - 30% Third - 20% Fourth - 10%
Any undistributed monies will revert back to the club

CLASSIFICATION FOR APRIL 2 & 3, 2023

REGULAR CLASSES - The following classes will be provided for both dogs and bitches: Puppy, 6 Mos & Under 9 Mos; Puppy, 9 Mos & Under 12 Mos; 12 Mos to under 15 Mos; 15 Mos to under 18 Mos; Novice; Amateur Owner Handler; Bred by Exhibitor*; American Bred; Open; Winners; Best of Breed Competition

Bred by Exhibitor Class Eligibility (revised 09/02). The Bred-by-Exhibitor Class shall be for dogs that are: 1) six months of age or older as of the first day of the show; 2) not Champions on the date of closing of entries for the show; 3) Individually registered with The American Kennel Club as of the date of the show; and, 4) Owned or co-owned by any of the breeders of record as of the date of the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which a dog from the Bred-by-Exhibitor class or division if it becomes eligible, there are no restrictions as to who may handle. *The BBE class will not be offered in age divisions at this event.

NON-REGULAR (ADDITIONAL) CLASSES - Involving Single Dog Entries -

Winners of the following classes will compete for Best of Breed Competition and therefore must meet all AKC requirements for Non-Regular Classes involving single dog entries.

Veteran Dog Class - A class for dogs six (6) years old or older.

Veteran Bitch Class - A class for bitches six (6) years old or older.

Best of Breed Competition

Best Head and Best Gait: Upon the completion of Best of Breed competition there will be two non-regular AKC Classes, Best Head and Best Gait. Entry fee for each of these two non-regular classes is \$10.00. Use the "additional classes" box on the entry form to enter.

NON-REGULAR (ADDITIONAL CLASSES) - Involving Multiple Dog Entries: As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

STUD DOG CLASS - For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the other regular classes, or if a Champion of Record in Best of Breed Competition but **MUST** be entered in the Stud Dog Class. The Get **MUST** be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional class fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The Class will be judged on the merits of the Get.

BROOD BITCH CLASS - Same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

BRACE CLASS - Two dogs of the same Breed or Variety of Breed that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Only". The dogs comprising a Brace **MUST** be named at the time of entry. In making entries for "Brace Class Only" full particulars must be given for each dog on individual regular entry forms.

TEAM CLASS - Four dogs of the same Breed or Variety of Breed that are similar in appearance, performing in unison, and presented by a maximum of four handlers. All dogs competing in team competition must have at least one common owner. If a dog which is to be part of a Team is not entered in another class, it must be entered for "TEAM Only". The dogs comprising a Team **MUST be named at the time of entry**. In making entries for "Team Class Only" full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class or for Best of Breed and entered as part of a Team **MUST** be marked accordingly in the space provided for Additional Classes "TEAM Class". If more than one Team is entered by the identical owner, the dogs comprising EACH Team must be so designated - Team No. 1 and Team No. 2, etc.

AWARD OF MERIT ROSETTES

At the conclusion of Best of Breed competition, the Judge may award at his/her discretion up to two Irish Wolfhounds (dogs and/or bitches) who have competed in the Best of Breed judging that show exceptional merit as deserving of an Award of Merit. Best of Breed, Best of Opposite Sex, Winners Dog and Winners Bitch, Select Dog and Select Bitch are not eligible for the Award of Merit.

**** OBEDIENCE TRIAL CLASSIFICATION ****

The particular class you desire to enter must be shown on the entry form. Dogs entered in breed classes may be entered in these classes by paying the 2nd entry fee of \$25.00. Prizes for which dogs in one class compete against dogs in one or more other classes at the Trial shall be awarded only to dogs that earn Qualifying scores. **Qualifying score required** for all prizes in Regular Classes. "DOG" means either sex. Move-ups will be allowed at this trial per AKC Regulations. Females in season are not permitted to compete. If a female is withdrawn from competition because she came into season **and** the show secretary is notified no later than one-half hour prior to the start of the first class in the trial, PVIWC is required to refund the entry fee minus a processing fee of \$3.00. **Qualifying scores are NOT required** for ribbons and prizes in the Non-Regular Classes. **Awards for the four placements** in these classes shall be based solely on the number of points earned.

All Entries are to be Mailed with Fees to Christina Buckner, PVIWC Show Secretary, 1348 Sycamore Ave., Annapolis, MD 21403. **Entries made on-line must be submitted with payment prior to closing.** Acknowledgement of entries will be made as soon as practicable after closing by mail with printed confirmations of entry. Should such acknowledgement not be received by the exhibitor within a reasonable time, please notify the Show Secretary.

Entries Not On Official AKC Entry Forms and photocopies of entry forms without the Agreement and Rules are not acceptable.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Entries will not be accepted without fees or signatures.

A Recording Fee of 50 Cents and an event service fee of \$3.00 will be required for each dog entered at any Licensed or Member Club Show, Obedience or Rally Trial.
