**PVIWC and the Show Secretary have no obligation or responsibility to provide service through a public address system or other means for the purpose of calling or locating dogs that are not brought into the ring when required.**

CONSULT Judging Program (pages 4 & 5) for Judging times scheduled.

-Dogs May Arrive any time prior to their scheduled time of judging. Dogs Not Required for further judging will be excused.

-All Dogs present must be on a leash or confined to their ex-pens except when being judged or when in the exercising ring.

-Exhibitors will be Governed by any rules of civil authorities' building and parking restrictions.

-This event may be cancelled due to extremes in weather or other conditions considered to be deleterious to the health and safety of dogs, exhibitors, judges, and fanciers. No refund of entries will be made in such case.

-The PVIWC, Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

-All trophies must be claimed before the closing of the show at which time they become forfeited. None will be mailed. Sweepstakes Cash Prizes will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before judging of the next class begins, and the Show Secretary advised at once. The Show Secretary and the PVIW Club disclaim any liability for cash prizes after the judging of the Sweepstakes is over.

Notice Regarding Trophies: Best of Breed Trophy and all Challenge Trophies will be awarded in the ring. Any trophy not awarded in the ring will be available at the Trophy Table and must be claimed prior to the awarding of Best of Breed.

The PVIWC reserves the right to substitute unavailable trophies with ones of equal or greater value. Any unclaimed trophies not collected the day of the event will not be forwarded and will become the property of the Club.

**REMINDERS:**

- 1) This Club does not agree to arbitrate claims as set forth on the official AKC entry form for this event.
- 2) NO Dogs may be left unattended at the show site overnight.
- 3) Please pick up after yourselves and your hounds while on the grounds of the show site and the hotel grounds.

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater. If no points are available for the Best of Winners, the number of regular class dogs in both sexes are added together and compared to the point schedule. If the total sum of regular class dogs and bitches meets or exceeds the number of competitors needed for one point in its sex, the Best of Winners will receive one championship point.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

Division 3 is comprised of: District of Columbia, Kentucky, Maryland, North Carolina, Tennessee, Virginia, West Virginia.

### TRANSFER OF ENTRIES

**CONFORMATION:** Dogs may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is presented to the Superintendent/Show Secretary at least one-half hour prior to the scheduled start of any regular conformation judging at the show.

**OBEDIENCE OR RALLY:** A transfer (i.e. From an obedience class to an obedience; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible provided the Club offers transfers. Transfers from an "A" to a "B" class at the same level are allowed provided the Club allows transfers. The request for a transfer must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit.

**Robert Joseph Brehl**  
**October 2, 1945 to June 24, 2024**

Bob Brehl was both brilliant and modest and had many identities. Few people knew he held a doctorate in biology with a primary focus in genetics from Notre Dame; spoke five languages; taught himself Russian over summer break; was *the* health expert of the Baltic states for the U.S. Defense Intelligence Agency (he once recounted visiting a country that had no mail system nor addresses assigned to houses); he went lobster diving in Maine – in the winter; he was a professor of biology in Iowa; retired from the Navy at the rank of Commander; or that while living in Florida, he drove his Wolfhound around in his MG sports car. To say he was exceptional is an understatement.

Bob held many more passions than identities. At the very top of this list were his Irish Wolfhounds. Bob lived with and bred Irish Wolfhounds for over 50 years. He once said he had always admired the breed, and so it was natural that as soon as he was able Bob brought home Padrick. He acquired Padrick in 1972 just before he married his life partner, Deirdre O’Leary (Dee) – Padrick was a surprise for her. Over the following wonderful ten years, Padrick enriched Bob and Dee’s lives in ways they never could have imagined. Bob and Dee made the conscience decision to never be without a *pack* of Irish Wolfhounds after Padrick crossed the Rainbow Bridge. Thus began their passion of showing and breeding Irish Wolfhounds, and, as a geneticist, Bob appreciated the gravity of breeding.

As in most things, Bob showed grace and humility in and out of the show ring. For Bob, conformation was more than a process of breeding and more about comradery. Of course, Bob wanted to champion his hounds, but not at the expense of others. He would be the first to congratulate the winner, be it a class or Best of Breed win. He mentored countless others to show. At the specialty shows and at Nationals, Bob and Dee would be found surrounded by friends old and new – his Wolfhound entourage – unraveling the nuances of the show ring for the novices. One case in point stands out in my memory. It was summer in New England at a very well attended specialty show. Bob asked someone, someone he felt was ready to show, to take his bitch in the ring for him. This young woman had never been in a show ring before and gravely doubted she was ready. Bob felt she was and encouraged her to take the plunge. She did and placed second or third in the class. Now she is an AKC judge. Bob touched so many lives through his Irish Wolfhounds and loved every moment of it.

A wonderful memory of Bob’s imprint on the bred is one involving Sam Ewing III. Bob was visiting Sam at the farm soon after Sam had imported (on loan) a stud dog from Germany. Bob asked how the new dog was working out for him. Sam said something of the sort, “that damn dog hasn’t done a damn thing.” I’m sending him back. Bob asked Sam if he had talked to the dog about his duties? Sam replied that he didn’t speak German. Bob did. Fluently. Bob had a chat with the German dog regarding the necessity of his visit. Bob called Sam a few days later to check on the dog’s progress . . . all was fine, and Bob received a pup from one of the sired litters (there were many).

Bob also gave his time and energy to his regional club. As early members of the Potomac Valley Irish Wolfhound Club (PVIWC), Bob and Dee had held nearly every position there was. Bob had been President, Vice President, Board Member many, many times over, and held nearly every committee position at one time or another. Bob was one of the main architects of the Club’s current By-Laws. He and Dee chaired the very successful Boutique Committee for more than twenty years. The Boutique was a year-round endeavor that culminated in the annual PVIWC Specialty Show. It was always spectacular! Bob literally poured his heart and soul into his work for the Club.

May Bob be joyously reunited with Dee, Padrick, and the many Irish Wolfhounds who followed in Padrick’s footsteps. Robert Joseph Brehl October 2, 1945 to June 24, 2024

When they finally had a litter, I still wasn't sure having a puppy was a good idea- but every weekend I was at his house, in the puppy box. One little boy would crawl to me the minute he heard me, and Bob's wife Dee kept saying I HAD to take that puppy, he had chosen me. Bob made it happen, and that puppy was Dylan O'Ros. From that minute on, he was "Daddy Bob." Mentor, friend, guide, Breeder. Bob was there when Dylan nearly died from a drug reaction, and on through 3 more boys. Any question, any need, Bob was always there. He did the same for the club.

Bob served PVIWC in numerous ways. Besides helping Dee run the boutique, he served on the board for many years, was President, Show secretary, and numerous other positions. He loved participating in parades, especially DC and Alexandria, and taking his dogs to festivals and shows. For some, Bob may have been the face of the club. He was passionate about the club and devoted much of his life to it.

After Dee died, Bob continued the Boutique, and breeding, but his heart wasn't in it, and he stopped breeding. In the past few years, he had lived in Florida in memory care.

SO much of my life, and so much of PVIWC, were influenced by Bob. PVIWC has definitely felt his absence. We dedicate this specialty to his memory.

## AKC Code of Sportsmanship

**PREFACE:** The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

## Irish Wolfhound Breed Standard

**General Appearance** - Of great size and commanding appearance, the Irish Wolfhound is remarkable in combining power and swiftness with keen sight. The largest and tallest of the galloping hounds, in general type he is a rough-coated, Greyhound-like breed; very muscular, strong though gracefully built; movements easy and active; head and neck carried high, the tail carried with an upward sweep with a slight curve towards the extremity. The minimum height and weight of dogs should be 32 inches and 120 pounds; of bitches, 30 inches and 105 pounds; these to apply only to hounds over 18 months of age. Anything below this should be debarred from competition. Great size, including height at shoulder and proportionate length of body, is the desideratum to be aimed at, and it is desired to firmly establish a race that shall average from 32 to 34 inches in dogs, showing the requisite power, activity, courage and symmetry.

**Head** - Long, the frontal bones of the forehead very slightly raised and very little indentation between the eyes. Skull, not too broad. Muzzle, long and moderately pointed. Ears, small and Greyhound-like in carriage.

**Neck** - Rather long, very strong and muscular, well arched, without dewlap or loose skin about the throat.

**Chest** - Very deep. Breast, wide.

**Back** - Rather long than short. Loins arched.

**Tail** - Long and slightly curved, of moderate thickness, and well covered with hair.

**Belly** - Well drawn up.

**Forequarters** - Shoulders, muscular, giving breadth of chest, set sloping. Elbows well under, neither turned inwards nor outwards.

**Leg** - Forearm muscular, and the whole leg strong and quite straight.

**Hindquarters** - Muscular thighs and second thigh long and strong as in the Greyhound, and hocks well let down and turning neither in nor out.

**Feet** - Moderately large and round, neither turned inwards nor outwards. Toes, well arched and closed. Nails, very strong and curved.

**Hair** - Rough and hard on body, legs and head; especially wiry and long over eyes and underjaw.

**Color and Markings** - The recognized colors are gray, brindle, red, black, pure white, fawn or any other color that appears in the Deerhound.

**Faults** - *Too light or heavy a head, too highly arched frontal bone; large ears and hanging flat to the face; short neck; full dewlap; too narrow or too broad a chest; sunken or hollow or quite straight back; bent forelegs; overbent fetlocks; twisted feet; spreading toes; too curly a tail; weak hindquarters and a general want of muscle; too short in body. Lips or nose liver-colored or lacking pigmentation.*

### List of Points in Order of Merit

*Typical.* The Irish Wolfhound is a rough-coated Greyhound-like breed, the tallest of the coursing hounds and remarkable in combining power and swiftness.

*Great size and commanding appearance.*

*Movements easy and active.*

*Head, long and level, carried high.*

*Forelegs, heavily boned, quite straight; elbows well set under.*

*Thighs long and muscular; second thighs, well muscled, stifles nicely bent.*

*Coat, rough and hard, especially wiry and long over eyes and under jaw.*

*Body, long, well-ribbed up, with ribs well sprung, and great breadth across hips.*

*Loins arched, belly well drawn up.*

*Ears, small, with Greyhound like carriage.*

*Feet, moderately large and round; toes, close, well arched.*

*Neck, long, well arched and very strong.*

*Chest, very deep, moderately broad.*

*Shoulders, muscular, set sloping.*

*Tail, long and slightly curved.*

*Eyes, dark.*

**Note**--The above in no way alters the "Standard of Excellence," which must in all cases be rigidly adhered to; they simply give the various points in order of merit. If in any case they appear at variance with Standard of Excellence, it is the latter which is correct.

I have given many lectures to trainee judges in SA and other States of Australia and New Zealand on judging Irish Wolfhounds covering all aspects of breed type and soundness. I enjoy giving back some of the knowledge that I have gained from over 36 years of judging.

In 2015, I wrote a book called *My Incredible Journey with Irish Wolfhounds* which sold out very quickly and is now being published by a company in London and is in the book shops now. My book was released by Austin Macauley Publishers Canary Wharf London 2020.

I have appeared in about eight movies and a mini-series, plus a number of TV adverts on Australian Television and represented Australia in Bangkok at the Kings cup (Boxing ).

I recently Judged the IWDB World Veteran dog show online and awarded best in show as well as the Breeders Groups. I am never happier than when judging at a dog show. Nothing gives me greater pleasure than to walk into a ring full of beautiful Irish Wolfhounds.

My most recent judging assignments in the USA occurred in August 2023, at the Rocky Mountain Irish Wolfhound Specialty in Colorado. This was my second time judging RMIWC. In 2024, I also judged the West Coast Irish Wolfhound Specialty in California. As you can tell, I am passionate about my judging, and I am very honoured to be chosen to Judge at your show.
